Below mentioned is the way to reach desired intercom number.

For Example:

- 1.) A resident is staying in OOTY block at 13th Floor 6th Apartment (F), then his/her intercom number will be 27136.

Block Code	Floor No.	Apartment No. (Alphabetically)
27	13	6

- 2.) A resident is staying in NAINITAL-1 block at 5th Floor 4th Apartment (D), then his/her intercom number will be 28054.

Block Code	Floor No.	Apartment No. (Alphabetically)
28	05	4

- 3.) A resident is staying in NAINITAL-2 block at 5th Floor 6th Apartment (F), then his/her intercom number will be 29056.

Block Code	Floor No.	Apartment No. (Alphabetically)
29	05	6

This is a number scheme for intercom facility.

The facility will be provided on fee of cost for all Airtel Broadband customers while the same facility will be chargeable for customers not using Airtel Broadband Facility @ Rs. 100/- per month.

The process to apply for the intercom facility is as below:

- 1.) For residents using broadband facility, they have to write a request mail to pulkit.tarneja@airtel.com stating the request for intercom activation where they have to share their Landline No., Airtel Broadband Account No. and Complete Address. After receiving the request, a service request will be raised and facility will be activated within 2 working days of time.
- 2.) For residents not using Airtel Broadband Facility, they also have to write a request mail to pulkit.tarneja@airtel.com stating new request for Intercom Facility where they have to mention their name, Address and contact no. to pick up the order request and login the application facility will be activated within 2 working days of time.
